RICR Title 218 – Rhode Island Department of Human Services Chapter 20 – Individual and Family Support Programs Part 2 – Rhode Island Works Program Rules and Regulations

 - 2. Any veteran's disability pension benefits received as a result of any disability sustained by the veteran while in the military service.
